‘It was a very busy couple months for the Gibbons Fire Department, they ended the year 2022 with a lot of accomplishments and training under their belt.

In September 2022, the Gibbons Fire Department decided to purchase an AED to donate to the Gibbons Community School.

AEDs are such an instrumental piece of equipment when life-saving measures are needed in patients in cardiac arrest.

The Gibbons Community School staff have their First Aid and AED training certifications, but after the AED was donated, they invited some members of the Gibbons Fire Department to provide them with an AED refresher.

In October 2022, the Gibbons Fire Department was fortunate enough to spend two very busy, yet educational days doing a Vehicle Extrication course with Randy Schmitz.

Randy is a Captain and Extrication Instructor with the Calgary Fire Department, he is also a TERC Judge, a Chairman with the Alberta Vehicle Extrication Association, a Magazine Columnist for several Fire Fighting magazines, the Creator of the Vehicle Extrication gloves “Schmitz Mittz,” and he runs Extrication courses across Canada and the U.S.A.

Randy is well known in the firefighting community and to learn from him requires booking well in advance.

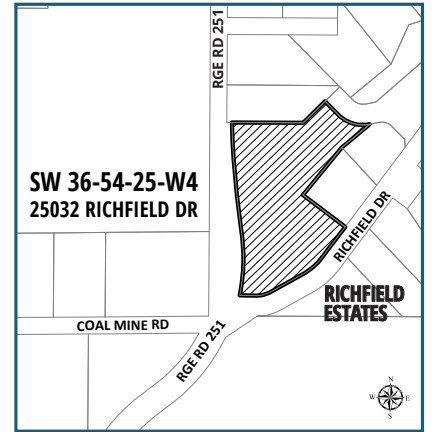

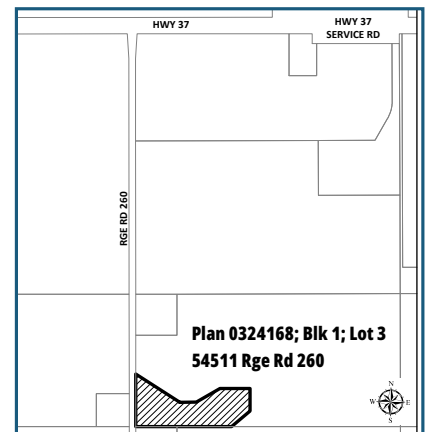

Morinville Art Club is celebrating 45 years this year

This year marks The Morinville Art Club's 45th anniversary, and the club is inviting new and experienced artists to join their weekly sessions.

Morinville Art Club President Rozanna Moore McConnell has been head of the club for the past five years but will step down from that role later this month at the Annual General Meeting (AGM) on Jan. 31.

"I do believe that the group is still wishing to do something commemorative, probably in conjunction with Festival Days as per usual," she said. "I'm really excited about it being 45 years. I've never been part of a group this age."

Although specific anniversary plans have yet to be decided, the Morinville Art Club will start the first of two 12-week studio sessions at the Morinville Community Cultural Centre after the AGM on Jan. 31. Doors open at 6:30

p.m. with the AGM at 7 p.m.

The remaining 11 weekly sessions take place on Tuesday evenings from 6:30 p.m. to 9:30 p.m. The second session will run from September until the end of November. The cost for each 12-week session is \$40.

"We always encourage people to bring their own work and work on their own thing," Moore McConnell said of the weekly studio time, noting that at less than \$5 per week, there is little in the way of activities to match the price and provide camaraderie as well. "I get so much feedback from the other artists saying, 'We really don't touch anything until it's time we come back, and we start working on things again.'"

Moore McConnell explained that the club is open to anyone interested in art at all experience levels. The club is not exclusive to painting. Photographers, woodworkers, carvers and sculptors are all welcome.

"It's a way to express yourself, and it's really important to do that in whatever way feels good to you," she explained. "To be part of the art club is

a way to open up to new ideas, a way of seeing things, but also to have someone to push you... or have that conversation about how it feels to be making art." Moore McConnell said the energy and attitude of the Morinville Art Club are loving and welcoming to all artists and all levels.

The local artist said her art journey is one where she shifted from the Bob Ross art style to doing abstract art. During that time, both types of art

were equally welcomed. "Any time I've presented my art with Morinville Art Club, it has never been looked down upon," Moore McConnell said.

The Art Club expects to show and sell art during this year's Morinville Festival Days and at the annual Farmers' Market Christmas Market.

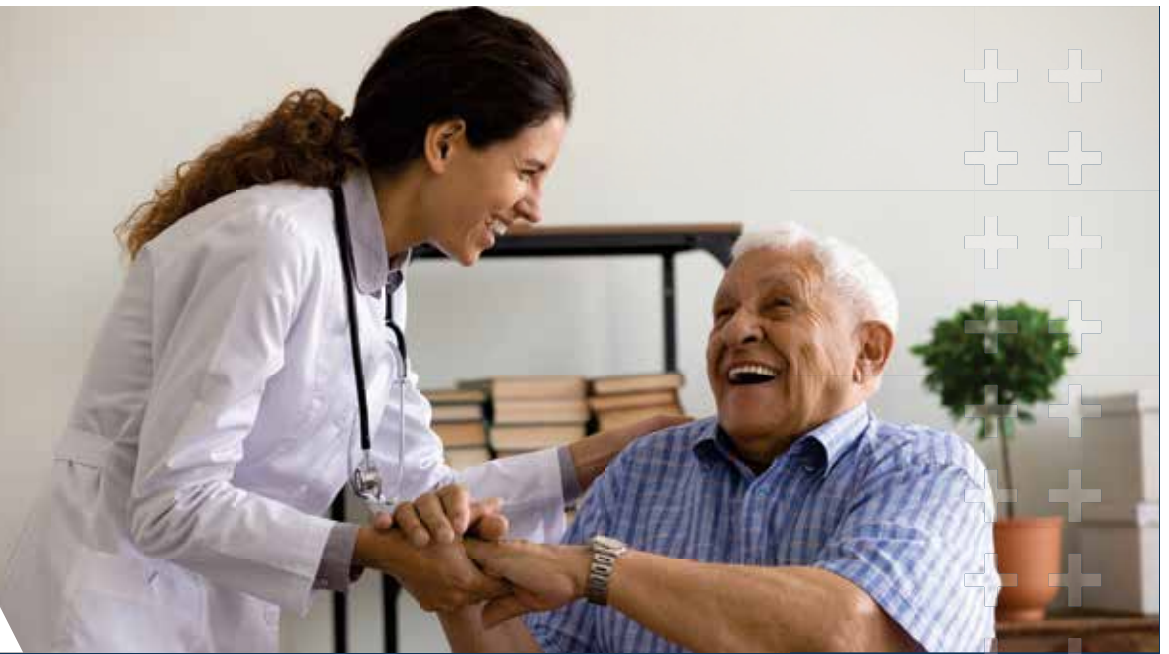

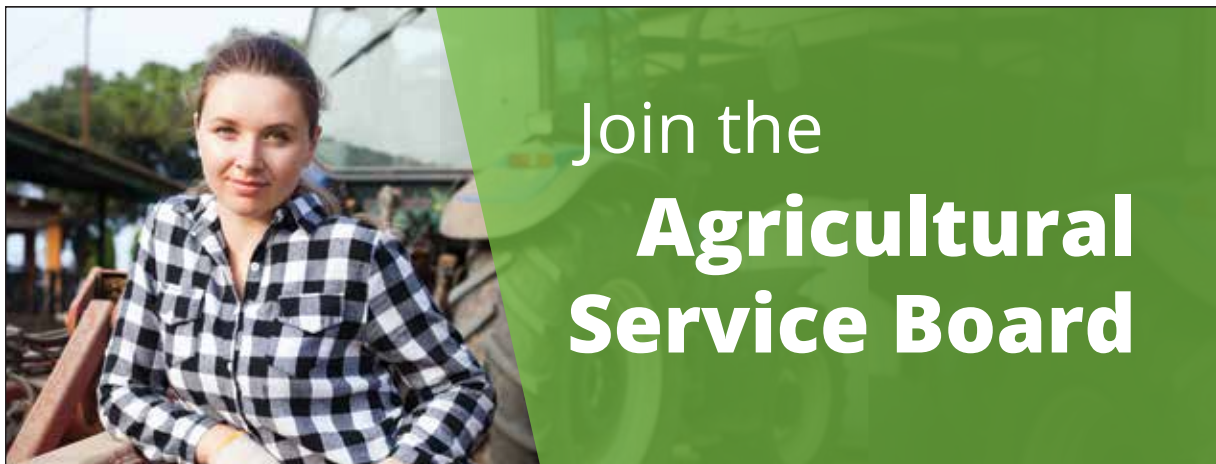

Fees and Charges Amendment Bylaw 5/2023 approved to remove surcharge fees on credit card payments

At the January 10 Regular Meeting of Council, Council approved the Fees and Charges Amendment Bylaw, removing the surcharge to credit card payments accepted by the Town.

Due to unforeseen challenges in the implementation and wanting to ensure that Morinville residents are not forced to pay the surcharge due to a lack of payment

alternatives, effective immediately the Town of Morinville will no longer be adding the 2.6% credit card surcharge to credit card purchases.

The Town is working diligently to process refunds to those who have made payments and incurred the surcharge to ensure refunds or account credits are provided.

The Town accepts credit cards for all payments except for payment of property taxes.

Town of Morinville scraps credit card surcharge

Surcharges on credit card payments to the Town of Morinville will be eliminated for this year following approval of a measure introduced at Tuesday's council meeting.

All three readings of a bylaw to amend the town's 2023 Fees and Charges Bylaw were passed at the meeting.

The surcharge was a new fee for the use of credit cards when paying for town services that were included in the 2023 Fees and Charges Bylaw, adopted in December.

The change will see the town reverting to 2022 payment procedures, in which credit cards were accepted without a surcharge for all payments to the town except taxes.

"The intent for it was to ensure that where credit card usage was at the discretion of the resident, we were able to recoup the cost of processing fees," Financial Services manager Travis Nosko said of the surcharge.

"It was never our intent with the surcharge to generate revenue for the municipality," he stated. "Nor did we want to see residents left without another option than credit cards."

But within a few days of the surcharge being instituted, it was realized that in some circumstances,

the registration software used at the Morinville Leisure Centre and Morinville Community Cultural Centre provided no other payment option but credit card use.

"We came to the conclusion that for now, the best recourse is to remove the surcharge in order to ensure residents are not required to be out that money when booking services," said Nosko.

One result of dropping the surcharge will be that payment of property taxes is no longer a possibility.

Nosko explained that the cost of credit card processing fees on property tax amounts was not something the town is willing to cover, as compared to the smaller costs for MLC and MCCC fees.

Other measures for dealing with credit card service fee charges are now being examined.

Residents who have already paid the surcharge will be eligible for refunds or account credits.

"Just so council knows, we are actively looking to connect with anybody who has incurred a surcharge to make sure we refund or put a credit, whichever the individual requests," said Nosko.

Mayor Simon Boersma credited the administration with dealing with the situation promptly after it had been recognized.

"I appreciate the speed at which administration

worked in order to ensure residents are looked after," he said.

The motion for the third reading was proposed by Councillor Scott Richardson.

"I think that the intent of this bylaw was good," he said.

"But obviously, there were unintended consequences."

Richardson suggested that if measures for credit card payments for property taxes were brought forward in the future, the community would need to be better informed.

"A lot of people thought we were generating revenue," he said. "Just making sure the message is clear would be better."

The third reading of the amending bylaw passed unanimously.
