MCHS hosts 2023 Cheer Provincials; Wolves take second place

The Morinville Community High School (MCHS) Cheer team hosted ACA/ASAA Cheer Provincials on Apr. 14 and 15, the first time the school has hosted a provincial competition since 1997.

The two-day event featured elementary, junior high and high school competitors demonstrating their skills in the Landrex Arena at the Morinville Leisure Centre.

MCHS put a bid in to host provincials back in 2019, but due to the pandemic, it would not be until this year that the event would happen in town. The event drew roughly 16 teams of five to 30 athletes, all vying to be deemed the best in the province. It also drew record attendance.

“This has been quite the undertaking,” said MCHS Cheer Coach Amanda Bulger ahead of the weekend competition. “It’s incredibly exciting and super stressful all at the same time. It’s also very bittersweet. I’m excited for the event to just happen already, so I just stop stressing about everything that needs to happen. But that also means that our season is coming to an end, and I’m not ready to stop working with this amazing group of young ladies.”

Bulger said that the team has had a wonderful season and finished in either first or second place at the various competitions they entered.

“The girls have worked incredibly hard to increase the difficulty of our stunt and pyramid sections in the last month,” Bulger said. “I could not be

more proud of them and everything they have accomplished this season.”

The competition commenced Friday night with Day 1 of the ASAA (Alberta Schools Athletic Association) High-school Provincial Cheerleading Championships. Saturday morning began with the ACA (Alberta Cheerleading Association) Elementary and Junior High Provincial Championships. St. Kateri and G.H. Primeau had teams in that competition. Saturday afternoon saw more high school cheer competitions. High school scores were tabulated based on teams’ two-run totals.

MCHS competed in two divisions

this year: the All Girls Advanced Division and the Game Day Division. The All Girls Advance Division was a two-and-a-half-minute routine consisting of a cheer, stunts, tumbling, jumps and dance. The Game Day routine is three minutes and consists of four shorter routines you would see performed on the sidelines of a sporting event.

The MCHS Wolves took second place in both of their competition categories.

The Georges H. Primeau Coyotes took third place in the Median Division, and the St. Kateri Tekakwitha Academy Bisons took fourth place in the Elementary Novice Division.

ANNUAL VEGETATION MANAGEMENT PROGRAM

Every year, CN is required to clear its right-of-way of any vegetation that may pose a safety hazard. Vegetation on railway right-of-way, if left uncontrolled, can contribute to trackside fires and impair proper inspection of track infrastructure.

For safe railway operations, CN will conduct its annual vegetation control program on its rail lines in the province of Alberta. A certified professional will be applying herbicides on and around the railway tracks (primarily along the 16 – 24 feet graveled area/ballast). All product requirements for setbacks in the vicinity of dwellings, aquatic environments, and municipal water supplies will be met.

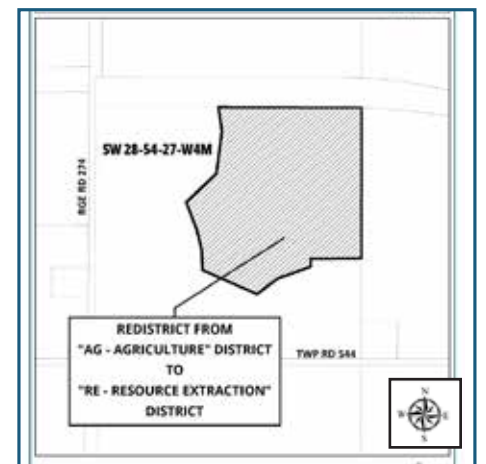

Morinville launches pilot Shuttle Service for Seniors 55+ residents offered access to low cost transportation options

The Town of Morinville is launching a pilot shuttle project for seniors, running from April to September 2023. This service will be reaching Morinville and Sturgeon County residents 55+. This pilot project was approved at the January 24, 2023, Regular Meeting of Council.

Shuttle Service for Seniors

- Excursion locations have been chosen to cover educational, social engagement and service access needs for seniors.
- Transportation fee for return trip to each venue location is \$10 plus GST. Any additional costs acquired at each venue are the responsibility of the rider.
- The Rendez-Vous Centre, Aspen House and Morinville Community Cultural Centre

have been designated as pick-up and drop-off locations within Morinville.

- A minimum booking of 13 people is required 72 hours in advance of transportation start time in order for shuttle service to run. Money will be refunded to registered participants if minimum requirement is not met.

To view complete schedule, visit: www.morinville.ca/seniorservices. In addition to the Shuttle Service for Seniors, the town has introduced a pilot Bus Rental Service for Seniors.


This service is available for groups of seniors 55+ who would like to rent a charter bus for a specific date and time. The cost of the bus rental will be the responsibility of the renter and will fluctuate depending on the

location and duration of the trip. A portion of twelve bus rental fees may qualify for a subsidy from the Town of Morinville.

"The Town of Morinville is very excited to be offering this pilot project for Morinville and Sturgeon County seniors. This transportation

service provides a great way for 55+ residents to gather with friends, explore new locations and pick up essential everyday products." explains Barb Adamson, Community Development Supervisor. Morinville Lions Club name the Citizen of the Year

Citizen of the Year Award for her work taking in and assisting Ukrainian families fleeing the war in that country.

Morinville Online did a profile piece on Stalzer and the Kornienko family in January of this year. At that point, the family was her fifth since the previous fall. As of Friday night's award, Stalzer had assisted six families, with the seventh set to arrive on April 23.

Stalzer said she was honoured to receive the award; however, her motivation for helping is humanitarian.

"I feel humbled. I don't think of my volunteerism as volunteerism. It's a mission, something that I have to do," Stalzer said.

In our January profile, Stalzer said that if people have the time, the space, and the passion to house a

family, it is extremely fulfilling. "I'm in touch with all my families, and it just creates a wonderful feeling that you can do something," she said at the time.

That viewpoint remains.

"I'm able to do it because I'm completely retired, and I do have financial funds," she said, noting that she has also received gift donations from various sources.

In addition to her trophy, Stalzer also received \$500 from an anonymous business.

A Second Good Citizen

The Lions also recognized their youngest nominee for Citizen of the Year, 11-year-old Reese Primeau, for past and present volunteer work in the community with an honourable

mention.

Primeau began volunteering as a helper at the nursery at church when she was just three years old. She accompanied her mother to volunteer at Heritage Lodge and Aspen House a year later.

Seven years later, Primeau still volunteers for the seniors, bringing her piano books to play for the residents there. She also plays bingo and word games with the seniors.

Primeau was pleased to receive the honourable mention. "It feels amazing. I feel very proud," Primeau said. "I like helping others and sharing."

In addition to a plaque, Primeau also received a \$500 cheque from an anonymous business.

A Third Good Citizen

Long-time community volunteer Bev Lussier was the second honourable mention. The Lions recognized Lussier for her extensive volunteerism with the Lions Club of Morinville and the Morinville Legion Branch No. 176. Lussier said she was surprised and honoured to be recognized with the honourable mention.

The long-time volunteer believes

volunteerism is important. "If you don't give back; you can't expect it back," she said. "It's a civic responsibility. There is nothing better."

Rendez-Vous Heritage Award

Another part of the evening's event was the Morinville Rendez-Vous Centre's Heritage Award presentation, which honours the work of dedicated volunteers at and outside the centre. Rendez-Vous Vice President Sharon Christenson made the presentation to this year's recipient, Judy Baker.
