Morinville has a new Land Use Bylaw. After giving the first reading of Land Use

Described as an omnibus amendment, its purpose is to overhaul the previous bylaw that was enacted in 2012 and has since seen 51 amendments.

The aim is to ensure it is clear, consistent and complies with provincial legislation.

The Land Use Bylaw now incorporates fire pit regulations.

Morinville seniors engage in community policing dialogue at Coffee with Cop event

The Morinville **RCMP** Detachment wanted to hear from local seniors, and about two dozen came out to the Morinville Rendez-Vous Centre on Thursday, February 15, to speak with Acting Staff Sergeant Lew Simms.

The Detachment's second Coffee with a Cop event allowed residents to drop by for a coffee and

share questions, concerns, and thoughts on policing in the community.

The group asked Simms about various concerns, including the adequacy of police coverage in the community, traffic concerns, speed limits, fraud prevention, crosswalks, and aggressive dogs, among other topics. Simms also conveyed a wealth policing info,

of Restorative Justice programs and Fraud Prevention education, the latter of which he plans to present to the Rendez-Vous members later.

Of particular interest to many attendees was information on how they could safeguard themselves against crime. To that end, Simms provided information on the Alberta Rural Crime Watch Association's

an informal chat to including the value RAVE, a web-based communication platform RCMP members use to give real-time alerts to Alberta community members.

"This is a very effective program because it goes out in real-time," Simms said, noting that as of that time, approximately 471 people in Morinville and Sturgeon County signed up to receive the real-time alerts.

The alerts, which

are both operationand educational, could include "be on the lookout for (BOLO) alerts, crime prevention, victim services, and district crime activity reports. The alerts are sent by email, text message or phone call, selected by the user at the time of sign-up. Those interested in RAVE can sign up at uralcrimewatch. ab.ca/l/rave.

Sgt. Simms also recommended the Alberta RCMP app, which includes a map with crime hot spot maps to let area residents know of criminal activity in the

Morinville Council to ponder future with Edmonton Global

Morinville Town Council will be reviewing the town's participation in Edmonton Global, a regional investment promotion body.

At its regular meeting Tuesday council passed a motion to refer discussion of Edmonton Global to an upcoming committee of the whole session.

Councillor Scott Richardson moved the motion following a presentation to council by board member Tanis Kozak, in attendance at the meeting along with Malcolm Bruce, the organization's CEO.

"I think we need to understand whether this aligns with Morinville's current strategic priorities," Richardson said. "What does Morinville look like with Global. How it aligns with them going forward or doesn't align going with them forward.

The discussion is set to follow a special shareholders' meeting in June.

Incorporated 2017 as a non-profit corporation, Edmonton Global's purpose is to promote the Edmonton metropolitan region globally, with a focus on attracting and retaining business investment and trade. Morinville joined in May of that year as one of 14 municipal shareholders paying annual fees based on population and tax bases to support the organization's operations.

The other shareholders are Beaumont, Devon, Edmonton, Fort Saskatchewan, Gibbons, the City of Leduc, Leduc County, Parkland County, St. Albert, Spruce Grove, Stony Plain, Strathcona County and Sturgeon County.

At the meeting, an ad hoc working committee was formed to meet with Edmonton Global's board of directors over the next six months and discuss possible improvements to its operations.

Morinville Mayor Simon Boersma chairs the committee. The participating mayors are Dan Deck of Gibbons; Bill Daneliuk of Beaumont; Rod Frank of Strathcona County; Cathy Heron of St. Albert; and Amarjeet Sohi of Edmonton.

Morinville gave notice in December 2020 that it was withdrawing from Edmonton Global, a decision made by council during the 2021 Budget deliberations.

The withdrawal was rescinded in September 2022 in a 4-3 split vote by council, following an administration recommendation to remain. At the time, Councillors

itself Rebecca Balanko, Stephen Dafoe and Scott Richardson were opposed to rejoining.

> The rationale for the recommendation was that continued membership would give the town a better longterm understanding of investment planning in the region and leverage the town's investment with the region to compete globally.

Morinville's monton Global fees for 2024 and 2025 are just under \$40,000.

According to Planning and Economic Development Manager T.J. Auer, the fee is projected to rise by about \$12,000 in 2026, but that figure depends on the annual budget approved by the shareholders and




Auer replied affirmatively when Councillor Maurice St. Denis asked whether administration now recommended that Morinville remain part of Edmonton Global.

from? It comes from reported crimes."

The Detachment held the first Coffee with a Cop event last November in the evening and drew a handful of participants.

Community and Infrastructure Services General Manager Sharleen Edwards said she was pleased with the February 15 turnout.

"I think they were really honest with our Detachment Commander about what they want to see," Edwards said of the participants. "I think he [Simms] did a great job just informing our community about some basic policing techniques and things that they use. This [event] was a great start to see engagement between our residents and our RCMP."

Morinville Rendez-Vous Centre Vice President Mike Dubas was also pleased with the event and said it was a good opportunity for seniors to connect with the RCMP.

"The youth in our community also play an important role," Simms said.




